

Below is a summary of your obligations regarding the management of First Aid emergencies in the workplace. Also included in this fact sheet is information regarding the occupational health and safety of workers. *First Aid Facilities and Services 2002 (WA)* Code of Practice provides practical advice about the selection, provision, maintenance and use of First Aid equipment, facilities and services at a workplace (including construction work and rural industry work). Compliance with the code of practice is enforced via the *Occupational Health and Safety Act WA 1996* and the *Occupational Health and Safety Regulation WA 1996*.

FIRST AID TRAINING

Per *Occupational Safety and Health Regulations WA 1996 s3.12* "A person who, at a workplace, is an employer, the main contractor or a self-employer person (b) **MUST** ensure that, as far as practicable, persons trained in first aid are available to give first aid at the workplace having regard to the type of hazards to persons at the workplace and the risk of those hazards; and the number of persons at the workplace."

First Aid Facilities and Services 2002 WA s 1.1 requires a first aid risk assessment to be completed.

Any fleet vehicles, sales representatives, company cars, or personal cars used for work require a minimum of a National Standard Workplace First Aid Kit.



*First Aid Facilities & Services 2002 WA s 1.11 states "All workers in **mobile workplaces**, such as bus and transport drivers, have access to a first aid kit"*

Therefore, those people that are required to do a lot of driving for work require a first aid kit in their vehicle.
